

Answers to self-test questions

Chapter 2: Finding legislation

Page 38

1. Section 39 of the Terrorism Act 2000 was amended by section 117(1)(3) of the Anti-terrorism, Crime and Security Act 2001. If you look at the entry in the *Chronological Table of the Statutes* provided in extract 2.3 on page 38 you will see:

s 39 am – Anti-terrorism, Crime and Security, 2001 c 24, s 117(1)(3)

Here ‘am’ is the abbreviation for ‘amended’.

2. Section 38B was added to the Terrorism Act 2000 by s. 117(1)(2) of the Anti-terrorism, Crime and Security Act 2001. If you look at the entry in the *Chronological Table of the Statutes* provided in extract 2.3 on page 38 you will see:

s 38B added – Anti-terrorism, Crime and Security, 2001 c 24, s 117(1)(2)

There is no shortcut method to finding this. You have to scan the extract looking for s. 117(1)(2) of the Anti-terrorism, Crime and Security Act 2001

3. The Commissioners for Revenue and Customs Act 2005 was brought into force by SI 2005/1126 Art 2. Look at extract 2.5 from the *Statute Citor* on page 40. You will see the *Commencement Order* listed here.
4. Look at extract 2.5 from the *Statute Citor* on page 40. You will see that sections 37 and 38 of the Commissioners for Revenue and Customs Act 2005 were varied by ‘2005 c. 15 s.38’. In order to provide a full answer you will need to find out the long title of the Act from its chapter number. We already know that the Serious Organised Crime and Police Act was chapter number 15 in 2005 from extract 2.4 from the *Alphabetical Table of Statutes* on page 39. Therefore, sections 37 and 38 of the Commissioners for Revenue and Customs Act 2005 were varied by section 38 of the Serious Organised Crime and Police Act 2005.

5. The Servants’ Characters Act 1792 can be found in volume 12(1) of *Halsbury’s Statutes* at page 66. This information can be found in the extract 2.7 from the *Alphabetical List of Statutes* on page 44.

6. Section 110 of the Serious Organised Crime and Police Act 2005 is in force. This can be seen from extract 2.9 from *Is It In Force?* on page 46. The entry also shows that it was brought into force on 1 January 2006 by SI 2005/3495. The full title of this

statutory instrument can be found in the list of *Commencement provisions* at the start of the extract: the Serious Organised Crime and Police Act 2005 (Commencement No 4 and Transitory Provisions) Order 2005 SI 2005/3495.

7. Statute law relating to special constables can be found in volume 33 of *Halsbury's Statutes*. In particular, statute law relating to appointment can be found on page 1304; to declaration on and nominations for on page 1199. Look at extract 2.11 from the *Consolidated Index* on page 47. Remember that the volume number is given in **bold** and followed by either the page or section number. Section numbers are shown in square brackets. Page numbers are unbracketed.
